- b) Corporations could sponsor certain Carter events such as Dance Night, Nutcracker, etc. (signage/representative from the corp. can attend/have booth, etc.)
- c) Carter music bands/dancers can be hired by corporations for their events such as Holiday parties; funds donated by corps can be divided into fee-forservice that the performing Arts area will be entitled to with balance going to Friends (to be allocated as per funding policies)
- d) Some corporations such as P&G will donate in kind such as gift baskets; donations in kind can be used as incentives in the Direct Donation campaign. Kevin to get more details on donations-in-kind.

7. CSPC-FRIENDS COORDINATION

Paolo provided an update on the CSPC funds and the disbursement policy to be followed. Mary provided some clarification.

- a) CSPC funds to be disbursed by CSPC no transfer of funds to Friends or comingling (as per School auditor's recommendation)
 - Approved purchases to be made from the Board's preferred vendor list. If a certain vendor is not on the list, the School can request the Board to have the vendor added
 - Funds from Friends and CSPC can go to the School's account and the School can make the purchases of the approved items; then provide receipt copies to Friends and CSPC
 - d) CSPC to utilize funds raised in the same year unless funds need to be carried forward for an earmarked purpose.
