1) APPROVAL OF MINUTES (September 12, 2017 meeting) (Tracy)

 Motion: To accept the minutes from September 12th 2017 meeting. Moved Natalie Hegarty Seconded Jan Patterson All in Favour – Approved

2) TREASURERS REPORT (Brenda)

- Our overall balance is now at \$34,155.
- Of this, there is approximately \$27,000 in committed funds yet to be spent (Choral risers, projector, Ballet barres, music computer)
- Bank deposit nearly full. Brenda to purchase new book for \$25

3) ACTION ITEMS UPDATE

- 22/2017 Completed Instagram Account now set up . 21 Followers thus far.
 Student Council have promoted through their Instagram Account. Plan is for students to follow both accounts.
- 23/2017 Completed Tracy's contact in busy time of year, so can't assist us in the short term with the Projector purchase. Vince indicated that the new projector needs to be purchased by December 1st for the Christmas Concert. Total cost is \$10,855 with tax, \$9,000 already approved.

- Motion: Moved Jan Patterson Seconded David Patterson that up to an additional \$2,000 be allocated towards the purchase of the Projector. All in Favour – Approved
- 24/2017 Completed Jan spoke with Chris Berwick who referred her to Lucy Sytnyk. Nominations are sought for all school awards form the teachers and student body. The Guidance Department has a Selection Committee organized by Lucy that collates and assesses all nominations for eligibility. The Committee then matches the Awards to the most appropriate and deserving student. Lucy is happy for Friends to provide the Criteria for the Friends Award.
- Motion: Moved Jan Patterson Seconded Anthony Viola that one Award be presented for each of Grade 8 and Grade 12. The Grade 8 Award to be a Certificate, the Grade 12 Award to be a plaque on a Theatre chair.
- Action Item: All Board members to come to November meeting with suggestions for the criteria for the Friends Awards.
- 25/2017 –Completed. Eliza reported that the website is now published and live. Jan and Eliza to maintain the website, Eliza producing a "How to Guide" for website maintenance.

4) ANNUAL FAMILY DONATION PROGRAM (Tracy)

- 31 families have donated since school resumed in September
- \$5,040 donated with seven \$250 donations.
- Further promotion to go out in November/December, focus on the purchase of a plaque as a Christmas present and also to receive a tax receipt before the end of the financial year.

Action item: Eliza to develop a bar chart which can be posted on the website which provides a monthly update for the funds raised for the years in relation to goal amount set for the year.

5) FRIENDS/CSPC FUNDRAISING MESSAGING (Niloufer)

- Most parents don't differentiate between Friends and CSPC.
- Therefore important that we provide a consistent message from both groups.

- Action Item: Anthony to develop a template email to go to donors asking them to reply with their plaque request (if any). Plaques will be struck for those who reply within a specified timeline (14 days suggested).
